There is nothing really to note since we did not have an in-person meeting in April. A lot of our members were either going to Sun-n-Fun or to the Expo in Charleston. There is a short report from John Stall on his experience at the Sun-n-Fun event.

Sun-n-Fun Report

I made a quick trip with some friends to Sun-N-Fun, attending Tuesday, the opening day, and Wednesday. I thought there were more people attending last year than this year. The crowds looked thinner as did the planes in the general aviation parking areas. Of course, that was the first two days. I heard that Saturday and Sunday are really crowded, when they give a discounted rate to Florida residents. There were more of the larger vendors than last year. A common theme I heard from them, and the smaller vendors concerned shipping times, and supply and employee shortages.

Garment and other avionic dealers had many avionics items out of stock, due to a worldwide shortage of microchips and glass screens. I didn't see anything new, but a lot of the foreign aircraft manufacturers had many of their aircraft on display. I assume it's because of the uptick in flight training. All the foreign and domestic light sport manufacturers seemed to be there and a few of them have electric powered aircraft with flight times of 1 ½ hours. That would give basic students an hour air work or pattern work and time in reserve. The idea is to swap out batteries for the next student. Cross-country work is another story. They have to work on that. I could see a flight school starting students in electric aircraft, then when they get ready for cross country training, upgrade to a fuel burning aircraft. Just my two cents. Some of them look sturdier than others.

The airshows were standard, but they had an A-26 Invader and an A-1 Skyraider in the military part of the airshow, which are rare aircraft to see flying. It was very windy during the night air show, which prevented some of the scheduled acts from flying. It poured on Thursday, the day we left for South Carolina. The grounds are swamped so we didn't really miss anything by leaving on Wednesday.

FAAST Blast - FAA Safety Briefing News Updates

General Information

- **FAA General Aviation Safety Outreach Initiative** – FAAST Notice Number: NOTC2310

The FAA is embarking on an FAA General Aviation (GA) Safety Outreach Initiative. It is intended to increase the GA community's awareness of safety management practices that could elevate the industry's overall safety performance.

The primary goals of the FAA GA Safety Outreach Initiative include:

- Increase the GA community's awareness of the Safety Attributes and the benefits of applying them
- Increase participation in the Safety Management System Voluntary Program (SMSVP)
- Reaching these goals will result in a desired outcome of a lower accident and incident rate in the GA community.

- **Medical Application Tracker Now Online**

Finding out the status of a flight medical is a click away under a new online feature announced by the FAA on 20 April 2022. The agency says pilots can now follow the progress of their medical through the system on the MedXPress website. Previously, pilots who wanted to check on their application had to call the Office of Aerospace Medicine. As soon as the application is submitted it will appear on the website and FAA staff will update it as it wends its way through the system.

"If you can track where your ridesharing car is or the status of a company delivering your package, pilots should be able to see online the real-time status of their application," said Federal Air Surgeon Dr. Susan Northrup. "We will continue to explore how we can be more transparent with the aviation community."

As soon as an application is submitted, it will appear in the pilot's MedXPress profile. Status updates will change as the application moves through the FAA's review process. If an application is deferred or denied, the applicant will receive detailed information through the mail.
